**Ethics Continuing Legal Education Program
Alternate Sessions on May 29, 30, and 31, 2013**

The United States District Court for the District of Puerto Rico is sponsoring a Continuing Legal Education (CLE) Program to be held on **May 29, 30, and 31, 2013**, at the Conrad San Juan Condado Plaza, San Juan, Puerto Rico. This is another extraordinary CLE opportunity offered **at no charge** to all members of the bar in good standing. **Every effort will be made to obtain accreditation from the Puerto Rico Supreme Court's Continuing Legal Education Program.**

This is a four (4) hour Program on ethics which will be offered on three (3) alternate dates to allow more participants to enroll. The lectures will be offered in the Spanish language. The registration will open at 12:30 p.m. and the Program will run from 1:15 p.m. until 5:35 p.m. For your convenience, a detailed agenda, speaker information, and lecture materials will be posted in the Court's CLE Program's website at <http://www.prd.uscourts.gov/?q=continuing-legal-education-cle-program>. The Program's featured lecturer will be Hiram Morales-Lugo, Esq., an international ethics consultant.

Space is limited to 300 participants, per session, with reservations to be taken strictly on a "first-come-first-serve" basis. Requests for reservation will **only** be received through the Court's CLE Registration Application.

Prior to submitting the CLE's Registration Application be advised that:

- Click on the CLE Registration Application link embedded in your e-mail invitation.
- The deadline for reservations is Friday, May 10, 2013, or until all seats are taken.
- Each attorney will make his/her own reservation.
- Only attorneys in good standing will be allowed to register.

- Participants must commit to attend the entire Program.
- Attorneys with confirmed seating who fail to attend must explain reasons in writing.
- **No telephone calls will be accepted.**
- Only attorneys with confirmed seats may attend the Program.
