INCREASES TO PANEL ATTORNEY HOURLY RATES AND CASE COMPENSATION MAXIMUMS UNDER THE CRIMINAL JUSTICE ACT (CJA)

The Administrative Office of the United States Courts has announced that due to the issuance of Executive Order number 14061 by the President Biden regarding 2022 federal civilian pay rates, 86 Fed. Reg. 73601 (December 22, 2021), inflationary adjustments will be made to the Criminal Justice Act (CJA) panel attorney hourly rates. *See*, 18 U.S.C. § 3006A(d)(1) and § 3599(g)(1). Effective January 1, 2022, the panel attorney hourly rates will increase from \$155 to \$158 for non-capital work and from \$197 to \$202 for capital work performed **on or after January 1, 2022**. Where the appointment of counsel occurred before January 1, 2022, the new hourly compensation rate applies to that portion of services provided on or after the effective date.

The non-capital rate increase will result in increases to the panel attorney case compensation maximums in non-capital cases. The adjusted panel attorney case compensation maximums are now as follows:

The new case compensation maximums apply to a voucher submitted by appointed counsel if that person furnished any CJA-compensable work on or after January 1, 2022. The former case

compensation maximums apply to a voucher submitted by appointed counsel if that person's CJA-compensable work on the representation was completed before January 1, 2022.

The new hourly rate and case compensation maximums will be updated in eVoucher through a national update.
